MEMBERSHIP (Cliff Rushton – (618.781.1156)



STATUS OF THE NEW CLUB HOUSE:

Our "Shelter in Place" directive has not stopped our Treasurer, Rich Wille from continuing the efforts to get the permits required to start the re-building of our clubhouse. The building application has been sent to Jersey County to review, provide input, recommendations and approval before we send them to the various required government agencies. We have spoken to Representative Monica Bristow and have asked her to follow up with the two Illinois agencies, IDNR and EPA, once these applications are received and she has graciously agreed to do so.

All the applications should have been sent out as of the printing of this newsletter and do not anticipate any delays in this application and approval process. Again, thank you Rich for your continuing efforts.

FROM THE COMMODORE:

Our Boat Club Family is once again temporarily without a meeting place. Rest assured, planning, permitting, and construction are not halted, and your Board is working **HARD** to get our new building up as soon as possible.

I could tell you all about Coronavirus, the health impact it has had, and the fact that it's keeping our Boat Club Family apart. I think you guys know the score. **BE SAFE. I'm going to instead, focus on only POSITIVE POINTS.**

We're getting a Brand-New Elevated Clubhouse! Our former home was built in the 1950's and had suffered more than one flooding. 2019's submerging was over the Bar top and doomed our building due to cumulative damage. Our more tenured Members will remember how much water 1993 brought. Did you know that we have about 45 current members who were members in '93? You know who you are, **THANK YOU** for your loyalty.

As soon as possible, **We're reconstructing the mouth of our harbor.** While on our property for demolition and while the Mississippi River was low, Stutz Excavating removed much dirt/silt from the mouth of our harbor. This was just a start. When then time is right, Stutz Excavating will return to reshape the berm, add large rip rap, and shrink the mouth.

Most importantly, despite unfortunate circumstances, **our membership is holding strong.** Every year during the month of April we lose members due to non-retention. Last year, at this time, we lost 43 members. This year's attrition will be much lower. Moreover, the presentation of a fresh and attractive elevated building will be a magnet for new recruits.

Thank you for your patience and devotion. The Boat Club Officers and Board members ask you to **STAY POSITIVE** and spread positivity. We'll be back together soon and stronger than ever.
